Run a weekly free after school club open to all children.	90 children have accessed the after school club - this includes 15 children in receipt of pupil premium and 5 children on the SEND register.	for 2024/25 GoGeronimo will run the weekly football club and school football team due to staff shortages.
Increase the number of children taking part in competitive sport	School football team set up and entered into the league and cup for the first time in many years.	A staff member ran the football teams for 2023/24 - this made a small savings on planned costs.
Increase the involvement in active play at break and lunchtimes	Two MSAs employed which has enabled extra staff to be outside to lead and supervise games. This has been further enhanced by two members of school staff offering to man the dining hall so that extra staff can be outside.	Continue for 2024-25
To improve the equipment used in PE lessons to ensure high quality and engaging PE.	The Friends of Moorlands purchased wall apparatus which left £2000 for general equipment - further equipment for badminton, football and gymnastics was purchased.	
To provide transport to swimming sessions and competitions	School buses are used for weekly swimming sessions and to transport children to football matches and tournaments. This enabled full participation in these events. Swimming would not have happened without this.	There are now only two buses (rather than 3) this is limiting the impact that they can have and the amount of times that they can be used across the federation.
To provide a PE scheme of work that that is fit for purpose	Get Set 4 PE purchased for another year - all staff are using this and it has led to high quality PE lessons that follow the national curriculum and meet all statutory requirements.	Continue for 2024-25
Ensure that staff are fully trained to access and deliver the PE scheme of work	Training has not taken place this year - target and costings to be carried over to 2024-25	Continue for 2024-25
